## Sonography Studies in 3D/4D

Did you know that WRA has replaced all of its ultrasound units with GE Voluson E8 3D/4D technology? These extraordinary and flexible units allow us to perform highly detailed obstetric and gynecological diagnostic studies in 2D mode and engage 3D/4D utilities if we identify an anomaly necessitating further investigation. Although this type of examination can be requested, you need not indicate 3D/4D on your order, it's part of our protocol.

## Virtual Colonoscopy Meets Clinical Standards for Screening

The clinical evidence not only supports the use of virtual colonoscopy as a diagnostic tool for symptomatic patients who are unable to undergo a complete colonoscopy, it also supports the use of virtual colonoscopy as a screening test for colon cancer. The evidence was confirmed by The American College of Radiology Imaging Network's National CT Colonography Trial (ACRIN 6664), the largest multicenter prospective study comparing CT colonography, aka virtual colonoscopy, with the gold standard colonoscopy. Based on complete data from 2531 participants, the study concluded that CT colonography could detect polyps 1 cm or larger in nine out of 10 patients. Results matched those obtained with colonoscopy for intermediate to large-sized adenomas. The findings appeared in the September 18, 2008 issue of the *New England Journal of Medicine*.

Based on this evidence, Cigna and UnitedHealthcare have approved the use of virtual colonoscopy as a screening test for colon cancer. In general, virtual colonoscopy screening will be approved for average risk, asymptomatic patients beginning at age 50 if the patient's plan covers colon cancer screening. Please continue to advise all patients, including subscribers of Cigna or UnitedHealthcare, to check with their insurance company to confirm their benefits. Patients without insurance coverage are also able to avail themselves of this technology at a standard fee of \$800.

## New Prep for Virtual Colonoscopy

WRA's patient prep for virtual colonoscopy has changed to MoviPrep®, a prescription preparation. We have found this prep to be better tolerated and more effective than the previous Fleet kit. A prescription will be written for the patient and included in the prep package upon pick-up at WRA.
